Four properties are currently in some phase of development, one finishing construction, and three in engineering development, with the hope that we can have all our Bushman residents moved out of the Bushman building and into a Lodge or community home within a year. We've also completed some newly renovated areas in the Bushman building to serve our day program clients in new and exciting ways. It is awesome to see how the organization has changed and the momentum we currently have. I hope you share my enthusiasm and gratitude to God for all that He has allowed us to do in reaching our mission and vision for Hope Christian Services.

Supplemental Government funds sustained us as we continued to face challenges from the corona virus this year, being able to continue our full payroll and even use some funds to renovate sections of our Bushman building for our day program. FROM THE OFFICE OF THE CHAPLAIN

“ *Willing and Able* ”

“A man with leprosy came to [Jesus] and begged him on his knees, ‘If you are willing, you can make me clean.’ Filled with compassion, Jesus reached out his hand and touched the man. ‘I am willing,’ he said. ‘Be clean!’ Immediately the leprosy left him and he was cleansed.”

-Mark 1:40-42

Jesus’ healing of the man with leprosy is one of those passages that I just seem to go back to over and over again. For those of you who are unfamiliar with Old Testament Law, leprosy was one of the worst things you could have in that society. It was like waiting for your death sentence in solitary confinement. This is what I mean, the Law required that lepers be sent away from society, and if by chance one came close to another human, he or she had to yell, “Unclean! Unclean!” to warn others not to get too close. People were so scared of getting this disease themselves, lepers were left to slowly rot away alone in isolation. Very rarely would family or loved ones come to visit; it feels like a terrible way to pass.

If you can begin to put yourself in the shoes of this leper, it’s actually understandable that this man would phrase his request to Jesus as he did, “If you are willing...” It’s almost as if the leper had resolved that nobody, not even God, cared about him. So when he approached Jesus, it wasn’t a question of if he could, but rather if cared enough to heal him. Of course Jesus’ response, which the Bible says was fueled by his love and compassion, flipped this man’s

life around. And as a cherry on top, Jesus touched the man. Think about how much emotional healing this simple act would have been for someone who may not have been hugged in years.

Here’s the point, when helping others, someone has to be both willing and able. One without the other, doesn’t do any practical good. Imagine how pointless this story would have been if Jesus were not the Son of God and did not have the power to heal him. He would’ve said something like, “I’d love to help you, but there’s not much I can do.” Or even worse, imagine if Jesus were able, yet unwilling to help this man, “Of course I can heal you, but why would I waste my time?” We would feel like Jesus was an unfeeling monster.

I realize that as the pandemic is becoming less and less of a factor, many of the churches and volunteer organizations I’m involved with have been slow to rebound. Of course for a long time, many were not able, for many good reasons, to volunteer at or visit places like Hope, but now I wonder if it’s more a matter of willingness. With that, I want to make an appeal to all of you who love HCS and our residents, if you’re able to, please consider coming back and volunteering your time at Hope. I believe that if you are willing and able, God wants to use you to share the love of Christ to some of our residents and staff.


